Gov't of Ontario	<b>Ontario Made Manufacturing Investment Tax Credit OMMITC</b> <b>Newly announced enhancements</b> <b>Higher level of support</b> <b>Available to non-CCPC's as a non-refundable tax credit.</b>	The Gov't of Ontario has introduced the new Ontario Made Manufacturing Investment Tax Credit to help manufacturers lower their costs; innovate; and become more competitive. 15% corporate tax credit for eligible corporations on qualifying investments in buildings, machinery, and equipment for use in mfg. or processing. Up to \$3M/year. MEDJCT Ontario Gov't	<p><b>Protect Ontario Financing Program</b></p> <p><b>*NEW*</b></p>	<p>The new Protect Ontario Financing Program (POFP) provides immediate relief (loan program) for businesses that are facing significant tariff related disruption as a result of section 232 tariffs on steel, aluminum and autos. Working capital loans (ie. payroll, lease payments, utility payments) may be provided if approved by a third-party financial partner.
